4. Details of our assessment

Celsa Meltshop permit TP3639BH

Q1 returns for the meltshop for Q1 2021 were sent to NRW on time and assessed against permit conditions.

The permit carries a limit for particulate matter from A1 stack at 5mg/m³. Monthly averages for Jan, Feb and March were reported at 0.68, 0.72, and 1.21 mg/m³ respectively. Permit limits were therefore complied with.

Site also sent TOPAS data for the quarter from their monitor at Willows High school. Note, NRW Technical Guidance Note M17 (Monitoring) Monitoring Particulate Matter in Ambient Air around Waste Facilities states that; "Currently no UK statutory standards or limits exist for the assessment of deposited dust and its tendency for causing nuisance. Similarly, no official air quality criterion has been set at a European or World Health Organisation (WHO) level, although a range of national yardstick criteria from other countries is found in the literature. Gravimetric dustfall monitoring results generated by mass deposition gauges (normally Frisbee gauges) at sensitive receptors are usually compared with a "complaints likely" dust guideline of 200 mg/m²/day, the limit being applied to the individual monthly-average samples and not (for instance) the annual-average value."

The results showed maximum values occurring on Jan 1st and Jan 7th with 6.5mg/m³ respectively. Average PM10 figures for the quarter were 0.098mg/m³.
