4. Details of our assessment

This CAR Form is issued in regards to non-compliance with OSM 12 of OSM Modification Notice June 2009 made under the Water Resources Act 1991 - Section 88 Schedule 10 - Notice of Modification of Consent to Discharge.

DCWW submitted a OSM sample result (as a less than) that was higher than the permit

limit for Blaenau Ffestiniog STW (Permit CG0083401) - taken on 5th May 2020.

DCWW should have rescheduled this sample so that the sample could be used for compliance. This was made clear to DCWW in item 2.2 of NRW/DCWW catchup call on 28th September 2020.

Failure to reschedule sample is considered non-compliance under OSM 12 - "After becoming aware, or following notification that, a sample has not been taken on the Monitoring Programme pre-scheduled date, or is lost, or a result for that sample can not be reported, the Consent Holder shall record the details and reschedule the sample."

Please ensure that the sample is rescheduled and the results provided to NRW in order to provide 12 sample sets for 2020 for the purpose of compliance.
