4. Details of our assessment

An inspection was undertaken at Airfield Metals Ltd site EPR/AB3698CV on 30/03/2021 by Sally Wakeford and Linda Warrick.

It was a routine inspection following the issue of the new bespoke permit at the site.

The site was tidy, and some stone had recently been placed down to maintain the parking off the site and the hardstanding area on the site. The impermeable pad was relatively clean and clear, with waste stored around the outside of it. The concrete appeared to be in good condition, and drained to a ditch at the side of the pad, with a sleep policeman at the front. This then drained to an interceptor, the interceptor waste is emptied by and taken to Mekatek.

The oils are removed by Slicker, Tyres are taken to TD Tyres in Carmarthenshire.

No depollution was occurring at the time of the inspection. Although there was a car on the ramp.

The premises registration code for the site (CAK166) expired on 09/03/2021.

ACTION: Renew premises registration code and inform officers once complete.

In 2020 you consigned batteries 16 06 01 and Interceptor waste 13 05 08. No Catalytic converters, oils or antifreeze.

If you are consigning waste from the other site, which is currently operating under a T9 exemption, it will require a separate registered premise code. It appears that previously you have consigned waste from 2 different postcodes using the same premises registration.

The consignment note provided for inspection of the oil interceptor waste did not contain the quantity specified in Section B3 and no SIC code. The note was ok otherwise.

C4 – Storage, Handling, Labelling and Segregation – Permit Condition 2.1.1 – Cat 3 score

You have been given a category 3 score of the above permit condition as tyres were seen stored on the hardstanding and not contained within a RORO skip.

The operator is only authorised to carry out the activities specified in schedule 1 table S1.1 (the “activities”). Waste tyres must be stored within a RORO skip, either on hardstanding or on impermeable surface with sealed drainage to sump.

ACTION: remove tyres which are not stored within a RORO skip and ensure in future all tyres are stored in the appropriate manner.
