Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation introduces the following changes to the permit as a result of application by the operator:

- Expanding the permit boundary to accommodate additional storage of dried wood chip, and allow current waste stockpiles to be stored in line with the Fire Prevention and Mitigation Plan guidance.
- Adding 'drying' to the permitted treatments listed in Table S1.1 for the Material Recycling Facility
- Adding the discharge point G1 to the permit.
- Adding additional waste codes to Table S2.1 Permitted waste types and quantities for waste recycling facility
- Adding additional waste codes to Table S2.2 Permitted waste types and quantities for the open windrow composting activity.

As a result of the above changes NRW added a pre-operational condition for future development in regard to how wood chip is stored on site. This resulted in Condition 2.6 and Table S1.4 being added to the permit.

In addition to the above Natural Resource Wales also took opportunity to update the permit as follows:

- Amend Tables S1.1 of the permit to ensure clarity in regard to the permitted activities. The waste activities associated with Material Recycling Facility and the Open Windrow Composting are now presented in Table S1.1 as separate waste activities.
- Amend Table S1.2 to include the previously agreed operating techniques for open windrow composting which were removed as a part of a previous variation as a mistake.
- As a result of the above, the permit now includes two separate tables outlining the permitted waste types and quantities one for each activity S2.1 and S2.2.
- Removal of Condition 4.2.4 which is a legacy condition that should have been removed by a previous variation.
- The addition of Conditions 3.2.2 and Condition 3.2.3 which should have been included in a previous variation.

- Amending the permit to include discharge points S1 and S2 which should have been included in a previous permit and are not included here as a change in site activities.
- The addition of Condition 3.1 which was removed as a mistake as a result of a previous variation and the renumbering of conditions 3.2, 3.3, 3.4, 3.5 and 3.6 to accommodate the new Condition 4.1.
- The addition of Condition 3.7 which was removed as a mistake as a result of a previous variation.

The schedules specify the changes made to the permit.
