### 4. Details of our assessment

This was an unannounced, routine site inspection.

The final waste loads for the day were being tipped and the operator was in the process of covering the tipping areas with daily cover (site derived soils).

There was a small pool of leachate visible in a small hollow near the top of cell 4. This appeared to be in the process of being covered. Please confirm this has been covered.

The waste levels within the southern boundary of cell 4 are still being brought up to final height. Please confirm when final capping and seeding will take place.

There was a very slight landfill gas odour detected on site. This odour could not be detected during an offsite odour assessment completed immediately after the site inspection. This offsite odour assessment included the following areas: Newhall Road, Vauxhall Industrial Estate, Heol Estate and Bangor Road.
