Environment officer Laoni Tye visited site on the 8th June 2018 and met with site TCM Gareth Danter-Hill. The weather was mild and damp at the time of the visit and it had been raining previously. It was a planned, announced visit to conduct a general inspection with a focus on improvements that had been made to the sites infrastructure. Simon Mitchell, the sites manager accompanied us around site.

The site had improved a lot since the last visit. The area that was previously deep in wet mud had been cleaned up and new hardstanding laid down to assist with permeability. There was a new bund constructed along the bottom part of the site where there had previously been a gap to ensure there is no site run-off into the nearby watercourse. There was a drainage channel constructed which was acting as a silt trap from the top end of the site which appeared to be working as it contained a lot of sediment. The settlement pond and site drainage needs to be closely monitored to assess its effectiveness. Any improvements or changes should be included within the EMS.
