Step Up Skips Site Visit – Treharris, Merthyr Tydfil County Borough Council (EPR/ WP3499FR) – 19/07/2018

Environment officers Craig Coleman and Nessa Dearle attended Step Up Skips facility in Treharris, MTCBC on 19/07/2018 and met with Christopher Rees to undertake a routine site inspection. Thank you for coming to site on short notice to discuss your site processes and waste streams.

(B3) Site drainage engineering (clean & foul)

Whilst onsite the drainage was assessed; the site benefits from an impermeable, concreted surface to prevent any spillage from entering ground water. The drainage was funnelled in to an interceptor which is maintained on a biannual basis. The flooring is beginning to show signs of wear and tear and may require maintenance soon to continue to meet the required standards.

(C1) Materials acceptance

The materials that were being collected and sorted on site at the time of the visit all complied with the waste streamed allowed within the Step Up Skips permit.

(D1) Site security

The site is surrounded by a 7ft fence to deter would be intruders and has security cameras which overlook the yard and entrance to the site.

(D2) Accidents, emergency and incident planning

There are spill kits available at the facility in the event of any oil spillages.

(F3) Dust/fibres/particulates and litter

The overall condition of the site was very good, there was no litter on the floor and the boundary surrounding the site was also clear of litter and debris from site activity. There had been regular dampening of the surface to prevent dust plumes in the recent sustained period of hot weather.
