4. Details of our assessment

Purpose Of Compliance Assessment

Refer to two earlier CAR1 forms that cover the extended flaring at Lamby Way, due to contractual disputes between the landfill operator and the gas utilisation plant operator. Those compliance assessment reports gave guidance around a number of possibilities and especially around management of flares and the gas field while no extraction at all took place over a not insignificant time.

NRW has considered the compliance aspects carefully with regard to the landfill permit and the GUP permit (Infinis). The regulator understands that both parties were involved and that on at least two occasions it appeared that one party or the other had caused access for the other one to be difficult.

However, in the light of that the local authority require the contract with Infinis (or any other third party), it is reasonable to foresee that should contractual discussions turn into dispute (and they clearly can and do), then some form of contingency plan should have been available and deployed a lot quicker than the actual timeline of this incident.

Therefore the landfill operator is issued with a non-compliance with their permit JP3239ST.

Non-compliance: *A category 3 non-compliance is issued to the operator for allowing a situation to develop, that led to the flaring, rather than utilisation of landfill gas, over a prolonged time. This is a foreseeable situation and a considerable volume of useful gas has simply been burned. This recorded as a failure to comply with permit condition 1.1.1, General Management. It is an offence under Regulation 38(2) of the Environmental Permitting Regulations (consolidated 2016) to breach a permit condition or emission limit. Non-compliance score CCS3.*

The regulator recognises that effort went into trying to resolve this, but this noncompliance is about prevention, planning and foreseeability.

Action 1 Lamby Way Landfill JP3239ST: *The permit holder is to consider what actions it may take, or intend to take, to prevent this happening in the future. This could be a transference of permitted activities or contingency resource (staff and / or equipment) availability. Due: 31st March 2021*
