4. Details of our assessment

NRW received an incident report on the 30th March of excessive flies on a nearby property which the reporter thought was coming from Randall Parker Foods.

Randall Parker Foods were asked to investigate and a response was received on the afternoon of the 30th. Following the information provided by Randall Parker Foods, NRW

are satisfied that the evidence of actions undertaken as part of their Pest Management Plan demonstrates that they continue to follow the relevant control measures as required.

On the 31st March NRW Officers visited Randall Parker Foods, from their observations there were minimal flies experienced on site and the fly boards were clear. Officers were satisfied that Randall Parker Foods are unlikely to be the source of flies off-site on this occasion.
