4. Details of our assessment

An inspection of Waterston Car Breakers, permit number EPR/WP3298FZ, on 30 March 2021 by Sally Wakeford and Linda Warrick.

During the site visit it was noted that the site was well organised and displayed good management and segregation of wastes.

The tanks had been labelled as per the previous inspection request.

The area of hardstanding at the rear of the site was free and clear from oils and grease.

One vehicle at the rear, which we were informed at been depolluted, still contained windscreen wash. This vehicle however was still mostly on the impermeable pavement.

The impermeable pavement appeared to be well maintained and no cracking was obvious during the inspection.

We were informed that 300 cars had recently been taken to Sims Metals.

Hazardous waste requirements: Linda Warrick will provide information under a separate cover to this report.

TCM (Technically Competent Management) Requirement

Currently the site has no TCM of Certificate of Technical Competence (TOTC) holder. This is an ongoing issue that has been raised on several occasions during inspections.

Mr Horrocks previously explained that his brother would undertake the Waste Management Industry Training and Advisory Board (WAMITAB) qualification.

Please could you provide details of who is currently acting as TCM, and provide a copy of their certificate of qualifications.

Baled tyres for use in construction

You expressed an interest in using baled tyres to construct a wall at the rear of the site.

A maximum of 50 tonnes of baled tyres can be used for the purposes of construction can be used under a U2 exemption. You would need to register this exemption with NRW. Thee bales must comply with standard PAS108.
