Inspected 23rd March 2021.

Access to outfall was overgrown and accessing the outfall was difficult. Site maintenance to enable easier access for monitoring would be beneficial.

A check of the screen is needed to ensure it is in good working order and rags should be cleared from the outfall.

No discharge was seen at time of inspection.

Weather conditions: Dry and cold.
