4. Details of our assessment

NRW officers Phil Harper and Kate Llewellyn visited Ty Mawr Farm Landfill, Ty Mawr Farm, Llanfair Road, Abergele, LL22 8AA on the 15th April 2021 at 10:20 am. Griffith Wyn Griffiths accompanied the inspection. The site was operational at the time of inspection.

The weather was dry and sunny.

A copy of the Site Operating Manual which was reviewed in 2019 has been received and a copy has been taken for NRW records.

Waste Acceptance.

During the inspection it was noted that pieces of wood, plastics and metals had been deposited within inert waste and compacted down into the surface of the deposit. These wastes that are not permitted under schedule 3 of the permit. More effort should be made to inspect incoming loads of waste, when non-permitted wastes are discovered in a tipped load they should be picked out and deposited in the site skip.





The facility is an inert landfill as such only wastes that are listed in schedule 3 of the permit should be accepted. Please be aware that the incorporation of biodegradable wastes such as wood into the waste mass may lead to the production of landfill gases which should not be occurring.

Permit condition 2.8.1 states that “Waste shall only be accepted for disposal if:

- (a) they are listed in Schedule 3, and**
- (b) they are inert waste, and**
- (c) they are not liquid waste (including waste waters but excluding sludge), and**
- (d) all the relevant waste acceptance procedures set out in Schedule 1 of the Landfill Regulations have been completed, and**
- (e) they fulfil the relevant waste acceptance criteria, and**
- (f) they have not been diluted or mixed solely to meet the relevant waste acceptance criteria, and**
- (g) from 30th October 2007 they are wastes which have been treated, except for wastes for which treatment is not technically feasible.**

Waste Transfer Notes

A sample of waste transfer notes from the site have been reviewed. In some instances, waste is accepted at the site with incomplete waste transfer notes. The following errors have been noted.

- No EWC code shown for imported waste
- Season tickets which do not indicate that they refer to multiple loads
- Description of waste missing
- Tonnage missing

Sections LF1 to LF4 of the site Operating manual describe the site waste acceptance and rejection procedures. Of particular notes is LF1 which describes what information should be on a transfer note for waste entering the site.

All wastes must be described on a written transfer notes.

The note should include:

a. Identify the waste to which relates and state:

- i Its quantity and whether on transfer it is loose or in a container
- ii If in a container, the kind of container
- iii The time and place of transfer
- iv The European Waste Catalogue number

a. Give the name and address of the transferor and the transferee.

b. State whether or not the transferor is the producer or importer of the waste and if so, which.

c. (d) State with respect to the transferor and the transferee which, if any, of the following categories describe them and provide any relevant information, i.e. licence number and licensing authority or registration number and EA with which registered.

Please ensure that the waste acceptance and rejection procedures as detailed in sections LF1 to LF4 are being adhered to.

A Category 3 permit breach against waste acceptance has been applied. A warning letter has been embedded within this CAR form.

F1 Odour

No odours on site or outside of the site boundary.

F2 Noise

Site was operational during the inspection, no excessive noise.

F3Dust/fibres/particulates and litter

No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.
