Evaluation of Ambient Bioaerosols at Llanddulas Composting Facility

Bioaerosol monitoring was undertaken in accordance with Condition 3.4.1(b) and Table

S4.1 on 26th February 2021.

Table S3.2 specifies limits for bio-aerosol concentrations as follows:

- Total bacteria (TB) - 1000 cfu/m³
- Aspergillus fumigatus (AF) - 500 cfu/m³

Bioaerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.
