4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance the waste returns for SP Waste Services was reviewed.

G4 Reporting and notification to Natural Resources Wales - Cat 4

During the review on the 7th December 2020 it was noted that no waste returns for the period covering 1st October 2019 to 30th September 2020 was submitted for the site. Due to this an email was sent to Mr Pryce on 07/12/2020 requesting for the returns to be submitted by 21/12/2020. As no response was received a Compliance Assessment Report (CAR) (Report ID CAR_NRW0037356) was sent requesting for the missed returns to be submitted by 31/03/2021.

An email was received from Mr Pryce on the 31/03/2021 stating that the requested returns had been submitted to the waste returns team. As these returns were not yet on the system, an email was sent to Mr Pryce requesting proof of submission. No email was received therefore Ffion Quan contacted the waste returns team querying whether these returns had been submitted, which they state they haven't.

Action required

- Submit waste returns for Q4 2019, Q1 2020, Q2 2020, Q3 2020 and Q4 2020 by 25/05/2021.
