- Review of the quarter 4 water monitoring submission received 27th January 2021. Further submission received on the 5th February 2021 for Hg and Cd results.
- The 2020 Air Emission monitoring report was also received on the 28th January 2021.

Quarter 4 - 2020 Monitoring Submission**Effluent Emission****Quarter 4 October to December 2020 - Effluent Emission - W1**

- Based on the report submitted by Dairy Partners, the emissions at the W1 monitoring point appear compliant with the site's specified emission limits, over the Q4 2020 monitoring period. (E1)
- The operator also submitted the annual mass release values for Cadmium and Mercury over 2020. Based on the results submitted, the values are below the permit's annual emission limit

Air Quality monitoring 2020**Air (A1 - Extractive Monitoring)**

- The 2020 air emission monitoring exercise was undertaken on the 23rd of December 2020, which is within the monitoring time period specified by the permit (g1). The results were received on the 28th of January 2021.
- The report indicates that the boiler flues were sampled for NOx and the results were 128 and 133 mg/m³ (G4). These results appear satisfactory (E1).
