4. Details of our assessment

Monitoring of emissions April - September 2020 (Q2 and Q3).

Requirements - Condition 3.3.1 requires the operator to undertake monitoring as specified in tables S3.1, S3.2 and S3.3 of Schedule 3 of the permit. The results of that monitoring are required to be reported to Natural Resources Wales in accordance with Schedule 4 and table S4.1

Findings:

Q2 emissions to water (April -June 2020) Monitoring reports for emissions to water (W2) were received on 21/07/2020 with a minor typographical error correction submitted on 07/08/2020.

Q3 emissions to water (July-September 2020) Monitoring reports for emissions to water (W2) were received on 22/10/2020.

A number of parameters were not monitored in Q2 and Q3 due to ongoing COVID-related laboratory closure. All required parameters were monitored with the exception of AOx, total N, total P and PCP. Monitored emissions were compliant with emission limit values.

As confirmed in the previous assessment form CAR_NRW0036580 the operator will continue with in-house monitoring and close observation of effluent treatment performance to identify any potential quality deterioration. Contact should be maintained with the laboratory to ensure that testing can resume as soon as the lab is operational again, and should include any missed quarterly or 6-monthly monitoring parameters.

In line with NRW's regulatory position on delays to monitoring due to COVID-19 restrictions these **two CCS4 breaches of Condition 3.3.1** will be suspended.

Q3 emissions to air Monitoring reports for emissions to air were received on 22/10/2020. All emission points that are operational were monitored as required and all emissions were within the permitted emission limits.

Emission point A7 was not in use due to COVID-related machine closures.
