This was an arranged visit to meet with new owner Nick James and landlord for the site Gary Durkin, the inspection was carried out by Regulating Officers Steven White and Karl Lombardi.

The site was clear of waste at the time of inspection both Nick and Gary have put in a lot of expense and effort in clearing the site from waste left by the previous owner, securing the site with front gates and new fencing around the perimeter of the site, and clearing the site interceptor and drainage. Invoices for ~£50k have been seen for the work carried out over the past 6 months.

The amount of work carried out by Nick and Gary should be recognised as the site has not been compliant with its permit conditions for at least 3 years; it is good to see the commitment shown to getting the site compliant prior to operations beginning.

A previous Suspension Notice for the site has been rescinded, copies of the notice have been emailed and sent to Nick James.

The site noticeboard was checked, all the relevant info was included however, the NRW contact was my office number, if this number is rung out of normal office hours then it will not be answered - this will need to be changed to the NRW contact number of 03000 65 3000. This is the 24hr contact number which can be used for any out-of-hours incidents; Nick James was informed of this and said the phone number on the sign would be changed.

Subsistence fees were discussed and an action/payment plan will be put in place for the 2018/19 fees.
