4. Details of our assessment

A pre-planned inspection of the ELV depollution & dismantling operation located at plot 12a Waterston Industrial Estate, Waterston, Milford Haven SA73 1DP and operated by TBS Skips Ltd was conducted on 23/04/2021.

NRW Waste Regulation Officer James Kinkead conducted the visit as a quick routine inspection following a post-incident inspection of the neighbouring waste transfer station on plot 10. Both Philip and Steven Thomas of TBS Skips were present during the visit.

TBS Skips operate under a SR2012 no.14 permit (EPR-ZB3297TP) at the site.

Storage and containment of waste materials.

Since our last inspection, TBS have improved the secondary containment of engine oils on site by placing the double-skinned oil storage tank in a sealed metal container. This container holds >110% of the capacity of the main oil tank, is double skinned and has a drainage tap which was securely fastened at the time of inspection (see images 1 and 2 below).

TBS employees were able to show the dedicated equipment for removal of engine oil, coolant, fuels and air conditioning fluids from ELVs. These are decanted into suitable containers whilst depollution is occurring.

All depollution activities occur within the roofed building and all activities and storage of ELV components is on a sealed concrete pad served by an interceptor.

General management

The ELV depollution bay was clear and well organised. All non-liquid ELV components such as batteries and alternators were stored in segregated plastic containers within the roofed building.

The ELV scrap waste was clearly segregated from the WEEE materials within the shed – an issue that was previously identified but has now been dealt with by the site.

Scrap metals are being stored away from the ELV de-pollution bay on a concrete pad with sealed drainage.

A dedicated member of staff is trained in ELV depollution and a new training rota is being developed as part of a site-wide re-organisation of working practices. Staff were knowledgeable with regards to the site and depollution process.

No significant tracking of oils or materials could be seen from the main depollution bay to other parts of the site.
