4. Details of our assessment

As part of Natural Resources Wales' (NRW) routine assessments for compliance, the continuing competence of the Technically Competent Manager (TCM) at Frongoch Lead Mine was reviewed.

Permit Breaches:

C1 Staff Competency/Training - Cat 3; Permit Condition 1.1.4

According to NRW records, the continuing competence certificate of the site's TCM, Mr Skitt, expired on the 29th of May 2020. An email was therefore sent to Mr Skitt on the 19th of November 2020, requesting a copy of his latest continuing competence certificate or evidence of his registration with WAMITAB, as per NRW regulatory decision statement which acknowledges the impact COVID-19 restrictions may currently have on the ability of TCMs to undertake continuing competence tests. As no response was received, Mr Skitt was asked within the Compliance Assessment Report (CAR) (Report ID: CAR_NRW0037292) dated the 12th of February 2021 to send NRW a copy of his latest continuing competence certificate or evidence of his registration with WAMITAB by the 12th of March 2021. This has however not been completed. As Frongoch Lead Mine's permit conditions require that the operator 'comply with the requirements of an approved competence scheme', Mr Skitt's failure to respond to both requests has resulted in the site being scored for an additional category 3 breach.

In order to rectify the above breach, we ask that Mr Skitt send NRW a copy of his latest continuing competence certificate or evidence of his registration with WAMITAB by the 7th of June 2021. Mr Skitt should be aware that the site will continue to be scored until this is completed and that NRW can consider revoking a permit if an operator fails to comply with the requirements of an approved competence scheme. If Mr Skitt has any issues preventing him from completing the above within the timeframe given, we ask that he contact the officer noted above by phone or by email.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
