In accordance with permit condition 4.2.1, BOC Limited Margam (BOC) is expected to submit a report on its performance over the previous year. The report is expected to be submitted by 31 January.

In addition and in accordance with permit condition 4.2.2, BOC is expected to report within 28 days of the end of the reporting period, the monitoring and assessment carried out for its permitted emissions points.

A requirement following *Table 5.3 Performance Parameters* is the reporting of water usage annually. We would expect to receive this summary as part of water usage1 or other form as agreed with us but this has not been submitted. Previous CAR forms have stated that there is no evidence of this form being submitted since the permit was issued in 2007. The Inspector expects BOC to submit Water Usage1 form for 2020 and to continue its annual water usage submission to be fully compliant in subsequent years.
