## 4. Details of our assessment

This Compliance Assessment Report follows on going conversations with the Operator regarding the Technically Competent Manager (TCM) capability and attendance at the Installation. It confirms the current position and interim agreement.

Since mid-April, Tradebe Healthcare Ltd has been operating the installation without complying with Condition 1.3.1 (the Operator shall implement and maintain a management system, organisational structure and allocate resources that are sufficient to achieve compliance with the limits and conditions of this Permit) and Condition 2.3.2 (the Permitted Installation shall be supervised by staff who are suitably trained and fully conversant with the requirements of the Permit), and continue to do so.

Issues have arisen around the resilience of the organisation to supply the necessary and relevant TCM cover at the installation as required by the Permit.

NRW agree that reduced on site cover is acceptable up until the end of September 2021. This means that a competent and suitably qualified WAMITAB holder should be on site at the Installation for at least 3 days a week and available by phone and email on other days. The details of who the competent person is and when they are on site should be recorded daily and be available for inspection as requested by NRW officers.

It is acknowledged that the current Site Manager is working towards their WAMITAB technical competence qualification and this will be complete by the end of September 2021. If there is any delay in this the Operator shall make alternative arrangements to ensure that there is full time cover available. NRW also recommend that the Operator improves its resilience at the site with more staff WAMITAB trained and therefore able to cover the TCM role when needed.

**The lack of a full time TCM on site is a CCS3 breach of permit.** In accordance with the scoring guidance the first breach attracts a score. Due to the unforeseen circumstances in which the situation has arisen, and the fact that actions are in place to address this any future breaches may be suspended until 30<sup>th</sup> September 2021, subject to a formalised action plan being submitted to NRW by 14<sup>th</sup> May 2021 (see separate letter).

## Important information
