4. Details of our assessment

This was a pre-planned inspection carried out on site by Donna Muirhead (Waste Regulation Officer) and Gareth Lewis (Specialist Adviser Waste Policy) in relation to a report of a land slippage on site.

Weather conditions were damp underfoot, overcast, cold with some sleet.

The site was not operational, officers began the inspection by walking to the area affected by the slippage.

No recent operations appeared to have taken place because the site had been closed since 12th March 2021 due to insufficient waste acceptance as a result of the COVID19 Lockdown.

Officers had no concerns in relation to the slippage as it did not reach the stream and was in the middle of the track.



During the visit we could see that the material that had been accepted on site was contaminated and consisted of hard plastic, plastic wrapping, wood, what seemed to be tree/plant roots and a football. Section 2.8.1 (b) of you permit states waste shall only be accepted for disposal if they are inert waste.





A compliance classification score of 3 has been applied to Section 2.8.1 (b) of the permit. This is because photos show non inert items in the waste mass.

Whilst on site officers could see that underneath the surface of the waste the area was black with a bad odour.

It seemed that there was organic material decomposing, we could also see what looked like polystyrene balls or particles on the surface. When Officers scrapped back more of the surface the site owner Mr Wills also commented about the bad smell coming from the soil and that the odour wasn't right and the waste should not smell like that.





Officers have concerns in relation to the waste accepted under EWC 19.12.12. You must ensure that the waste you accept is inert and in line with your permit.

The Straw bales that were being used as a filter to stop silt from run-off entering the watercourse needs changing.

No mud was observed on the road.
