## 4. Details of our assessment

This was an unannounced site inspection carried out by Natural Resources Wales officers Donna Muirhead (Waste Regulation Officer) and Phil Harper (Waste Regulation Officer).

Weather conditions throughout the visit were dry, sunny and mild.

On arrival officers proceeded to the site office and met with and Ceira Jones. Officers proceeded into the permitted area of the site and met with Huw Jones who accompanied officers throughout the visit.

Discussions took place concerning the backlog of waste due to a machine breakdown and skips being in very high demand due to covid, the backlog in the yard would be reduced in 1 week.



The site was operational with waste being accepted and processed. Incoming waste was being deposited within the main waste transfer building ready for processing. Within the main waste transfer building the trommel and picking line wasn't running as staff were on their break.



The site surfaces were clean and free of any waste or debris.  
No issues were noted relating to noise, dust, mud, odour or litter.



A presence of seagulls was observed around the site however these were not scavenging upon waste being stored on site or appearing to cause an amenity nuisance locally at the time of the inspection.
