This site inspection was carried out on Thursday 15th April 2021 by Natural Resources Wales Officer Donna Muirhead (Waste Regulation Officer) and Dan Grant (Hazardous Waste Regulation Officer). Present was Lee Jones of Worldcare Recycling Limited.

Weather conditions throughout the inspection was dry and sunny.

The visit consisted of a brief inspection of the permitted area only, on this occasion no site documentation relating to this permit was reviewed.

No waste activities (apart from waste storage) was taking place on the site whilst the regulating officers was present. Only permitted wastes were observed within the permitted area.



Site surfaces were in good condition with no pools of standing water or rutting. The road outside the site was also clear of mud/debris.
