The non-compliance/s listed above was/were identified during our annual 2020 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works). 31.12.2020: OSM 13 - Sampling shortfalls not included on ASR.

09.07.2020: OSM 13 - A sample has not been taken on the Monitoring Programme pre-scheduled date and details recorded on the ASR state re-schedule date as "TBC".

23.03.2020: OSM 13 - A sample has not been taken on the Monitoring Programme pre-scheduled date and details recorded on the ASR state re-schedule date as 24.03.2020 but NRW have no record of a sample on 24.03.2020.

10.08.20: Update. OSM 123 - Incorrect recording of data on ASR.

31.12.2020: OSM 1 - Sampling shortfall - 1 shortfall for BOD.
