24/3/2020 - OSM 13 - a sample has not been taken on the Monitoring Programme pre-scheduled date and details of reschedule or cancellation has not been recorded on the ASR.

31/12/2020 - OSM 1 Out of hours - no out of hours samples for BOD, Ammonia or suspended solids.

The non-compliances listed above were identified during our annual 2020 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works). Our enforcement response is subject to further investigation.

## Important information
