4. Details of our assessment

The non-compliance/s listed above were identified during our annual 2020 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works). See more details below against each non conformance date.

31/12/2020: OSM 1 - Shortfall of data; the no flow record for the 30.04.2020 was submitted late, on the 21.04.2021, but there was no supporting photographic evidence so cannot be used (3 out of 4).

30/03/2020: OSM 13 - Incorrect entry on ASR "Missed and Rescheduled Samples" tab.

Our enforcement response is subject to further investigation.
