The non-compliance/s listed above was/were identified during our annual 2020 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works). More details against the non-conformance dates below:

31/12/2020: OSM 9 - Data for the 02/06/2020 was submitted late, on the 21/04/2021.

31/12/2020: OSM 9 - BOD result for the 31/01/2020 sent 30/04/2020.

29/01/2020: OSM 13 - A sample has not been taken on the Monitoring Programme pre-scheduled date and details of reschedule or cancellation has not been recorded on the

ASR.
