4. Details of our assessment

1st failure 01/06/2019 result 41mg/l
2nd failure 15/04/2020 result 26mg/l

DCWW confirmed that the BOD failure was caused by elevated solids present in the final effluent. The final tank was slightly hydraulically overloaded to protect compliance and to increase hydraulic capacity. It has a tertiary solids system incorporated into the top of the tank called a hodwax system. This consists of polystyrene beads contained in a mesh basket which the flow has to pass through on leaving the tank, and solids are captured in the beds. Maintenance of the hodwax is difficult as flows must be held in the system to allow the final tank to be taken offline to allow the beads to be cleaned by power hose, otherwise solids can be released if they are allowed to build up. It's believed that there had been an accumulation of solids in the hodwax which were released.

Significant remedial work at the site undertaken by installing an additional final settlement tank. Temporary set up at the moment to split flows between the original and new FST's but more permanent flow splitting arrangement to provide better control over the flows going to each final tank. We will also be considering whether to remove the hodwax in due course as whilst this aids the current set up, there is a risk associated with the hodwax system, and with increased FST hydraulic capacity we will no longer need to load the single FST as high.
