4. Details of our assessment

NRW Officer was accompanied around the site by Len and Shaun Davies. The focus of this visit was to look at the improvements that had been made to the hardstanding areas and to follow up on the improvements needed to the area of the shears and the specifically the bund beneath it.

The recent improvements to the hardstanding and tracks through the site appear to be holding up however the area leading up to and around the shears does need some attention.

Non Compliance:

B1 (Engineering for prevention and control of pollution) Category 2 Non-Compliance of permit condition 2.1.1. The site has a history of issues regarding the metal shears area. During this visit, as in previous visits, the area in and around the shears and it's bund was full of scrap metal, oil contaminated rainwater. This makes the bund unable to capture and retain any fluids that could potentially leak from the shears, and given the age and condition of the equipment, this appears likely. **This is a breach of condition 2.1.1 of your permit.** Please clear (and keep clear) the bunded area, pump out the oil contaminated water (remove to a suitably authorised facility) and repair the bund as necessary. Table 2.1 of your permit details the need for daily inspections of the bund and to keep it free of contaminated water. **This breach has been recorded as a Category 2 non-compliance.**

**Non Compliance:**

(C2) Management system and operating procedures: Category 3 Non-Compliance of permit condition 2.1.3. The hardstanding areas (including the tracks through the site) must be constructed and maintained in accordance with table 2.1 of the permit e.g. not subject to rutting, have sufficient durability to allow cleaning and shall remain free from standing water. During our visit the hardstanding area around the shears was loose and deeply rutted, this shows that the hardstanding has failed to be maintained. **This breach has been recorded as a Category 3 non-compliance.**
