4. Details of our assessment

We have reviewed the report '*Bryn Posteg Landfill Annual Report 2020*' submitted to NRW on 31 January 2021. This report included reporting as required by Permit EPR/RP3338TA.

Condition 4.2.2 requires that a report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January.

Point Source Emissions to Air Table S3.1

The results were received on 11th February 2021.

The engine was monitored, in accordance with Permit Condition 3.3.1 and Table S3.1 on the 15th December 2020. The emission limits for Oxides of Nitrogen (NO₂) and Volatile Organic Compounds (VOC) were 711mg/m³ NO₂ against an ELV of 500mg/m³ and 1295mg/m³ against an ELV of 1000mg/m³. These results are within the limits of uncertainty as specified in LFTGN08. It should be noted though that the NO₂ reading would be considered a breach if the level of uncertainty of 28% as stated in the report by Envirodat Ltd was used.

Annual Production/Treatment Table S4.2

Condition 4.2.2(b) and Table S4.2 require Landfill Gas combusted and Total Energy Generation results to be submitted by 31 January. These were submitted on 13th May. **NRW considers this a breach of Permit Condition 4.2.2 (G4 – CCS4).**

Action 1: Ensure future monitoring returns are submitted within the timescales specified within the permit.

Combustion figures show 1,155,567 and 4,509,005 normalised m³/year were combusted through the flare and gas engine respectively.

Results for Condition 4.2.2(c) and Table S4.3 (water and energy usage) were provided as part of the Annual Review of Permit EPR/BU7766IC, Bryn Posteg Landfill.
