The non-compliances listed above were identified during our annual 2020 data audit.

This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Our enforcement response is subject to further investigation.

In regards to efficacy monitoring conditions - Written agreements now supersede permit requirement, disinfection efficacy monitoring frequency is now aligned with Operator Self-Monitoring (OSM) requirements are set out in NRW guidance document 7.01 "How to comply with your environmental permit - Additional guidance for water discharge and groundwater (from point source)"
