### 4. Details of our assessment

Site Inspection carried out Waste and Environment Officer by Karl Attwood on 12/5/21

Upon arriving at the site I was requested to sign in and to ensure I knew the Health and

### Safety protocols when using and attending the site.

The weather conditions on the day of inspection were clear and dry and there were no concerns that would effect the inspection.

The site is protected with several security cameras located around the site, security fences and gated entrance that is locked in the evenings. There is no concern over vandalism or criminal activity. The entrance was clear from debris and the overall appearance of the site was very well maintained, with site workers activity ensuring the public areas were clear of any materials.

### Site Entrance and Security Gates



The site operates a one way system around the site which reduces traffic congestion and road markings are clearly visible, along with markings for walkways and covid distance markings ensuring safe distance is adhered to. Parking bays are clearly marked directly in front of the skips.

### Site Layout and Two-Tier System



The site is set out in a two-tiered system that provides a safe area to unload for the public

and allows the site operators to conduct their duties in a safe manner.

During the tour of the site perimeters I was able to see that all the designated recycle skips and containers were well maintained with no clear visible damage and that they were clearly indicated to what materials could be disposed in them. The walkways were also clear of any materials and no hazards were noted. The lower section of the site (no access to the public) was clear with easy access to all containers and skips.

- Please ensure that the gas container is emptied frequently and no canisters are stacked on top of one another.
- Collection of Fridges to reduce build up
