4. Details of our assessment

Site Inspection carried out by Waste and Environment Officer Karl Attwood on 13/5/21

The site was closed to the public on a Thursday, but the site was opened by Tommy Sykes (Health and Safety Manager) to allow the inspection to take place.

The weather conditions on the day of inspection were clear and dry and there were no concerns that would effect the inspection.

The site is protected with several security cameras located around the site, security fences and gated entrance that is locked in the evenings. There is no concern over vandalism or criminal activity. The entrance was clear from debris and the overall appearance of the site was very well maintained.

Site Entrance and Security Gates



The site operates a two tiered operating service with booking system to allow safe use of the site. This restricts numbers on site adhering to covid protocols. The skips and containers are clearly marked indicating which materials are to be deposited. No skips or containers were over flowing. There were furniture items that needed to be collected as they were building up but I was assured that they were due for collection. There was also a section containing tyres and fridge freezers that was locked up and secure. The lower section allowed easy access the skips to be removed without any issues. The container which stored gas canisters and paint was secure, however this was full and requires to be emptied and this was confirmed that this would be taking place.

- Please ensure that the gas container is emptied frequently and no canisters are stacked on top of one another.
- Lower area to be cleared from any materials that have fallen from skip upon transfer out of site
- Furniture to be removed as this was building up
