4. Details of our assessment

Site Inspection carried out by Waste and Environment Officer Karl Attwood on 13/5/21

Upon arriving at the site I was requested to sign in and to ensure I knew the Health and Safety protocols when using and attending the site.

The weather conditions on the day of inspection were clear and dry and there were no concerns that would effect the inspection.

The site is protected with several security cameras located around the site, security fences and gated entrance that is locked in the evenings. There is no concern over vandalism or criminal activity. The entrance was clear from debris and the overall appearance of the site was very well maintained, with site workers activity ensuring all areas were clear of any materials and were wearing correct PPE.

Main Entrance



I was taken to the far end of the site where I was shown where the large storage facility is being used by Denbighshire County Council following the fire at Lon Parcwr. This area is maintained well with materials being stored neatly. In the same area, containers were being used in order to separate recycling materials. Again there were no concerns of excess materials from the containers over spilling onto the forecourt. The containers were full but I was assured that they were due for collection.

Heading back towards the entrance, there were several skips and bins that were neatly stacked to the side of the yard and all were free of any obstructions. Another storage facility contained dry mattress materials that were bailed up ready for collection. They were stored with ample space between the walls and were not stacked more than 2 bails high. I was advised that they were due for collection as they do not store more than what was in the unit. To the side of the unit containing the dry materials were mattress materials that could be stored outside. Again they were stacked 2 bails high ready for collection. This was stored to the side of the yard and posed no obstruction to the operation of the site.

I was then taken through the operating facility where site operators were dismantling the mattress that are brought on to site. The stacks were separated into specific piles and were neatly stored. In the sorting room, the site operators were dismantling the mattresses and sorting the materials into specific piles. The area was well ventilated and all employees were wearing appropriate PPE.
