## 4. Details of our assessment

This unannounced site inspection was carried out in response to 8 incidents reported to Natural Resources Wales (NRW) during the evening of 16/03/21 and the morning of 17/03/21 in relation to odour and smoke believed to be coming from a source on the industrial estate.

At the time of the inspection, the operator appeared to be operating in line with the permit.

The permitted CHP unit (NB1) was operational and the plume was barely visible.

The fuel that was being used in the CHP unit was a mixture of woodchip and biomass.

Following notification from NRW's Incident Communication Centre (ICC), the operator carried out investigations into the incidents reported to NRW between 16/03/21 - 17/03/21 and provided a response to NRW on 08/04/21.

As part of this response, the operator provided boiler performance data for NB1 between 16/03/21 (06:30)- 17/03/21 (12:30). The operator states that there were no events on the site's production log that would impact the quality of the flue gas/ emissions from the site.

It should be noted that members of the public sent several photographs to NRW on 16/03/21 which show emissions from another source on the industrial estate between approximately 17:00-21:50hrs.
