4. Details of our assessment

Site Inspection carried out by Waste and Environment Officer Karl Attwood on 13/5/21

Upon arriving at the site I was requested to sign in and to ensure I knew the Health and Safety protocols when using and attending the site.

The weather conditions on the day of inspection were wet after brief raining spell but there were no concerns that would effect the inspection.

The site entrance has a gated area which is secured at the end of each day and there is no concern over vandalism or criminal activity. Public access through the main gate to the end of the site and exit via a side gate. The site operates a booking system which manages the transport into the site. All members of staff were wearing appropriate PPE.

The site is a single level site with access to either ground level skips and containers. There are also skips with access via raised walkways. They were free from obstructions. All containers had clear signage to indicate what materials could be deposited. There were small areas that needed to be cleared from materials that had blown from the skips.
