4. Details of our assessment

Site Inspection carried out by Waste and Environment Officer Karl Attwood on 13/5/21

The weather conditions on the day of inspection were clear, and had just finished raining, however were no concerns that this would effect the inspection.

The site is protected with several security cameras located around the site, security fences and gated entrance that is locked in the evenings. There is no concern over vandalism or criminal activity. The entrance was clear from debris and the overall appearance of the site was very well maintained.

I arrived on site to conduct an unarranged site inspection. I was asked to sign in before carrying out the inspection and was made to confirm that I had the appropriate PPE.

The site operators were all wearing the appropriate PPE on site.

The site operates a two tiered facility. Road markings are clearly visible and free from obstructions. Car parking bays are in front of the skips were clearly marked and spaced to comply with covid measurements. The containers and skips had correct signage indicating what materials could be deposited. Full containers were closed off for use and were being prepared for collection.

The lower level was clear from obstructions and all containers and skips were positioned for easy collection.

- Chase the order of the new florescent tube case as this was split, exposing all the tube lighting inside
