4. Details of our assessment

Quarterly reporting of emissions – Q3 (Jul – Sep 2020) and Q4 (Oct – Dec 2020)

Monitoring for all emission points and parameters required by condition 3.3.1 was undertaken and the results reported within the timescales required by condition 4.2.3 of the permit.

Monitoring of emissions to air were submitted on 18/09/2020 for Q3 and 11/12/2020 for Q4.

All results for the emission points were within the emission limit values specified by condition 3.1.2.

2020 Annual reporting

Annual reports for performance indicator parameters and the solvents management plan were received on 28/01/2021, as required by condition 4.2.2 and Schedule 4 of the permit. It is noted that both solvent emissions and performance indicators were impacted by increased production due to EU exit preparedness. Solvent emissions continue to comply with the limits specified by Table S3.4.

Quarterly reporting of emissions - Q1 (Jan-Mar 2021)

Monitoring for all emission points and parameters required by condition 3.3.1 was undertaken and the results reported within the timescales required by condition 4.2.3 of the permit.

Monitoring of emissions to air were submitted on 22/03/21.

All results for the emission points were within the emission limit values specified by condition 3.1.2.
