4. Details of our assessment

Site Inspection carried out by Waste and Environment Officer Karl Attwood on 13/5/21

The weather conditions on the day of inspection were clear, and had just finished raining, however were no concerns that this would effect the inspection.

The site inspection was an un-scheduled visit. I was required to sign in and made to ensure

that I was wearing correct PPE. I was informed that IT Williams had been assessed by HSE the following week and had actions placed against them to make changes. These changes were ongoing.

One area that was being changed was the gated area of the transfer station. This is to be replaced with a new gate that can be closed and locked. There were also wall panels that had been replaced with a view of further panels being replaced.

General area where the waste materials are stored was maintained well with tidy piles of materials. The containers were kept to one side that allowed access to them and I was informed that the containers were ready for collection and are never over filled. I was informed that the remaining HSE areas of improvement were ongoing.
