4. Details of our assessment

Celtic Chemicals Ltd (CCL) is a privately owned company who carry out chemical dissolution and packaging; powders blending and repackaging; and storage and on-sale of

chemicals. The permit was issued in 2007 as a 'low impact installation' (LII) and it is a requirement that CCL provides an annual report which provides evidence that they still meet the LII criteria by the 31st of January annually.

The late submission of CCL compliance with Low Impact Installation criteria assessment for 2020 will result in a ccs score of 4. The Inspector would expect timely notification from CCL to ensure compliance with their environmental permit.

Following assessment of the annual submission, the subsequent observations were noted:

- Implementation of ISO14001 has not yet been undertaken by CCL. NRW would welcome it's enactment.
- NRW note that the commissioning of the water treatment system is ongoing with current aqueous waste produced by CCL being disposed by an authorised waste contractor. The Inspector would expect CCL to notify NRW nearing the end of the waste water treatment commissioning phase.

Other parameters described within the annual review form states the facility continue to operate under the criteria for Low Impact Installation.
