4. Details of our assessment

On 17 May 2021 a site inspection was undertaken by Sally Wakeford at Penhydd Farm

Recovery Ltd, Permit number EPR/WP3395ED.

The purpose of the inspection was to undertake a final inspection for surrender of the permit.

On site I was accompanied by Mark, who is the grandson of the occupier of the land. The site had changed hands approximately 8 years ago, and the current occupiers have not imported any waste to the area in that time.

A walk of the site was undertaken. The site is now fully grassed over and there was no evidence of non-compliant waste being imported to the site.

Having checked the records we hold, and speaking to the previous officer, it is noted that pre application advice has given for surrender a number of times, it was agreed previously that we would accept a low-risk surrender.

As the situation and operations on site have not changed through confirmation of a site inspection and review of the records, **I can confirm that this can be considered a low risk surrender.**
