Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Arranged site inspection of United Recycled Aggregates Limited. In attendance, Michael Edwards and Sally Wakeford of Natural Resources Wales along with Andrew Walters of Alun Griffiths. Purpose of inspection was to determine surrender application of site.

Currently site is non operational, however an agreement is in place to allow the local authority access to the site to reduce traffic on highway for access to adjacent CA site.

On arrival several skips were stored on the site, some of which included waste types not permitted under the conditions of the environmental permit. Mixed waste was also stored in the storage bays, this area benefits from impermeable surface with sealed drainage. However, under **condition 2.3.1 a)** Wastes shall only be accepted if; it is a type listed in **Table 2.3** of these standard rules.

As discussed on site this has been scored as a category 3 breach of permit condition 2.3.1a.

Action – As agreed please ensure that the wastes are removed from site.

Under **condition 2.4.1 and Table 2.4** wastes shall be stored and treated on hard-standing or an impermeable surface with sealed drainage system. It was noted during the inspection that the drains serving the storage bay areas were blocked.

Action – Ensure that the drains are cleared and provide NRW with drainage plans for the yard.

Under **condition 4.2.2** Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.

Action – Please ensure that waste returns are updated following the removal of wastes from site to a suitably authorised facility.

Please contact me once the site is clear of waste so that we can arrange a follow up inspection prior to surrender.
