**4. Details of our assessment**

On 07 May 2021 a routine site inspection was undertaken by Sally Wakeford and was accompanied on site by Paula and Hannah.

The site inspection focussed on general overarching compliance with the permit, following the period of Covid lockdowns and staff on furlough.

In general the site appeared well managed.

A boat is due on week commencing 17 May, when tonnage of baled wastes will have reached boat tonnage capacity.

**Maintenance:**

The pad in the main processing area requires some maintenance, which is planned for when the new shear is in place and activities are moved across. This is planned later in the year.

Area requiring maintenance:

**Drainage:**

Since the previous inspection further drainage improvements have been installed. There are now two holding tanks on the newer area of the site, along with additional bunding and drainage channels.

Tanks and interceptors were cleared in December 2020. Drains are cleared approximately every 3 months in the winter and 6 months during the summer months.

There was no evidence of any discharge of oils from the interceptor to the dock water.



### **Environment Management System**

The EMS has recently been updated. **Please provide a copy for our records.**

It is noted that operations will change over the next year, with the installation of the new shear and shifting of operations. Please ensure your Environment Management System is kept up to date with any changes on site, and any amended versions passed to NRW to ensure permit compliance.

### **Technically Competent Manager:**

Due to a number of recent staff changes the Technically Competent Manager role is currently being filled by Tony Davis until such time as internal staff can be suitably trained.



**Oil and Fluid Storage:**

It has been recognised by Celsa that the oil and fluid storage does require being stored under cover, as the containment areas for the oils fills with rainwater.
