4. Details of our assessment

To be read in conjunction with CAR_NRW0037420 which is the audit of the discharge permit at the site.

This was a pre-planned OSM audit carried out by Natural Resources Wales officers Emma Sharp and Jeremy Goddard, who were accompanied by Dŵr Cymru Welsh Water staff Michael Jones, Sarah Mowlam and Nick Elder.

The site has an active storm discharge permit (BP0110901) which was issued on 23/01/2018. The final sewage effluent and storm discharge from the same outfall pipe. During our site visit we could see the exposed outfall pipe on Llangrannog beach. It was difficult to inspect visually given its location. Since our site visit, DCWW have confirmed that the outfall pipe has now been buried under the beach.

Storm Screen

Condition 2.3.3 (c) Table S3.3 states that the screen aperture size of the storm discharge should be 6x6mm.

ACTION: Please confirm in writing the aperture size of the storm screen. If it has a greater aperture than the required 6x6mm then please advise on when the screen will be replaced with one compliant with permit condition 2.3.3 (c) Table S3.3.

On 31/03/2021 NRW received an email from Sarah Mowlam of DCWW confirming that there is a 6mm screen on the storm. Therefore this is no longer listed as an action in the report.

Storm spill data (EDM)

Following the visit, a request was made to Dŵr Cymru for monitoring data associated with Llangrannog STW. The data covered the period from 18/09/2019 to 18/09/2020.

There is no inlet meter at the site to measure incoming flows. There were no spills to storm during the period from 18/09/2019 to 18/09/2020. There is a storm tank on site which holds 116m³.
