## 4. Details of our assessment

This CAR form acknowledges receipt of a written protocol for monitoring point source emissions to water at TSP1, TSP2 and SESP, as stipulated by permit EPR/CP3795FY.

This information was submitted on 31<sup>st</sup> March, 2021, in response to the actions set out in CAR form, reference NRW0037454, which in order to minimise the risk of pollution, required Sims to carry out a review of their emissions monitoring procedures to ensure appropriate measures are put in place to meet the quarterly reporting requirements and to provide evidence that relevant personnel are trained in the taking and reporting of such, with evidence to be provided.

The protocol (Issue date March 2021) is comprehensively written with due regard to EA Technical Guidance Note M18 (Monitoring of discharges to water). It addresses the concerns previously raised by NRW regarding the frequency and regularity of carrying out and submitting monitoring results.

Sims' training record dated 31<sup>st</sup> March, 2021, indicates that 2 members of staff have received appropriate point source emissions training. Reference is also made to the protocol being available to site managers and supervisors and thus forming an integral part of the site Environmental Management System.

Providing the processes set out in the protocol are followed, Sims should successfully discharge it's responsibilities of gathering representative water quality data for the surface water discharged to the dock and submitting to NRW in compliance with the permit conditions. The information received is in accordance with the requirement of the CAR actions and is, therefore, considered acceptable.
