4. Details of our assessment

This was an unannounced site inspection by Regulating Officer Kathryn Bradshaw accompanied by Daniel Grant, Hazardous Waste Regulation Officer. Derek Pilkington was on site and accompanied us throughout the inspection. All asbestos waste is collected by Pilkington Asbestos Services Ltd (PARS) from the various waste producers and brought back to site. No waste is brought onto site by the general public or building contractors. There were no ongoing activities whilst we were on site.



The waste is double bagged at the place of production and brought back to the site where it is stored in one of two locked skips. See photo below of the inside of one of the skips.



The skips are provided by Acumen Waste Services and when they are full Acumen collect and replace with an empty secure skip.



PARS Ltd do have a hazardous waste producer registration but it has been registered in the name of Acumen Waste Services. It was agreed that when the registration is ready for renewal it should be registered in PARS Ltd as the organisation name, not Acumen.

The site is fully secure with perimeter fencing in good condition as well as CCTV that covers the inside of the building.



The inside of the building has a sealed drainage system with two tanks at the rear to contain any spillages. However as Derek Pilkington explained if they do have a spillage of asbestos the material is dry and is hoovered up. See photo below of one of the tanks for the sealed drainage system.



PARS Ltd also have a clinical waste transfer station permit but this is non operational with no current plans to become operational.
PARS Ltd explained they had been having problems with the consignee return spreadsheet that is downloaded from our website. They have a copy of the manual spreadsheet and were advised to continue to use this for the submission of their consignee returns.

Separate guidance will be sent on the other activities that were observed during the site inspection.
