Regulatory officer Jonathan LEE attended AJ Davies Car Spares (also known as South Wales Spares) on Station Road, Bargoed, Caerphilly, CF81 9AL on Thursday 2nd March August at 13:20. Weather was mild but overcast at the time of inspection. Met and spoke with business operator Mr Alan Hunt. The visit made was a final site visit, given the recent application for surrender of permit number **EPR-LB3133DS**.

No end of life vehicles have been depolluted at the site for over a year. No depolluted or non-depolluted end of life vehicles were present within the site. No waste tyres or batteries remaining on site. No visible oil contamination of the impermeable surface or hard standing areas of the site. No issues with drainage or interceptor at time of inspection. Oil containers stored within bunded area, no leaks or cracks in the walled bund were visible. Majority of used engine oil had been collected and removed from the site.

Materials remaining on site were limited to parts taken from depolluted end of life vehicles, these were primarily stored indoors. Some vehicle doors and bumpers remained externally. The operator noted that these parts would either be sold or appropriately removed from site as soon as practically possible given the imminent closure of the parts business.

Site was deemed secure at time of inspection, with metal fencing running the perimeter of the site and a lockable gate at the site entrance.
