Introduction

This is a part review of the Quarter 1 to Quarter 4, 2020 monitoring submissions made by the operator.

Annual Energy Usage, Water Usage, Performance & Sewer Discharge report have also been reviewed and acknowledged.

Point source emission to water results for emission point W2

Point source emissions monitoring

- The Operator have previously submitted a Schedule 5 notification stating a collapse of riverbank has subsequently damaged pipework carrying treated effluent to discharge point W2. This discussion can be found in a separate CAR Form: NRW0037846. The following discussion and associated scoring is for the assessment of monitoring returns only.

Quarter 1 Point source emissions – W2

- The Q1 (January to March 2020) submissions included the results for all quarterly parameters required over this period.
