4. Details of our assessment

Unannounced site inspection carried out by Michael Edwards and Sally Wakeford of Natural Resources Wales accompanied on site by Darren Hemming.

Waste Acceptance, Storage and Treatment.

Table 1.1 sets out the limits on specified waste management operations that are undertaken on site. No non compliances were identified with the listed waste management operations undertaken on site during the inspection with treatment limited to physical sorting and separation of wastes carried out on impermeable surfaces with sealed drainage.

Under **condition 1.2.1** only wastes listed in **Table 1.2A** and detailed in **Appendix A** of the environmental permit are permitted to enter the site. No non permitted waste types were identified during the inspection.

As we discussed on site, Natural Resources Wales is currently undertaking a review of waste exemptions. At present the site benefits from the use of S2 waste exemption to allow the temporary storage of certain waste types. It is unknown at this time whether the review will impact the suitability and use of waste exemptions in addition to environmental permits.

Infrastructure site drainage

During the previous inspection it was noted that cracks had developed in the drainage system on the lower level. **Condition 2.1.2** of the environmental permit, the site drainage and impermeable pavements are required to be inspected and maintained. Infrastructure maintenance and improvement works were being undertaken at the time of the inspection. Drainage plans have also been submitted since the inspection was undertaken and have been saved on NRW systems.
